Participation in Job Fairs:

On April 8, 2014, the employment unit hosted an informative and educational session entitled "Encuentro con Univision" at "Colegio de Cinematografia, Artes y Televisión". Managers of our Radio and TV staff delivered a lecture to students (half hour, each one) in which they discussed employment opportunities in Radio and TV and brought their personal work experiences through the years to students with the purpose of giving them a wide vision about what the stations do, how they do it and how the students need to prepare to look for those opportunities. Production & Operations Director (TV), News Director (Radio), Production Supervisor (Radio), Programming Director (TV) and News Director (TV) answered questions from students immediately after their individual participations.

Every head department lecture was followed with a video where employees explained to the students their functions and responsibilities in their departments. The video depicted employees from all departments, performing a variety of positions.

The event was advertised in the stations' daily TV newscasts (four (4) editions Monday through Friday) from 4/3/2013 to 4/8/2013; and in both radio stations (WKAQ-580 and KQ-105) from 4/3/2013 to 4/8/2013.

On September 9, 2014 the stations hosted their second event of "Encuentro con Univision" at Universidad de Puerto Rico- Humacao Campus. This was the first time the stations presented this event in the east area of the island. Managers of the Radio and TV staff delivered a lecture to students (30 minutes, each one) where they talked about employment opportunities in Radio and TV and brought their personal work experiences through the years to students with the purpose of giving them a wide vision about what the stations do, how they do it and how the students need to prepare to look for those opportunities. The employment unit was the first TV or Radio Station to presents this kind of event for students of this university. The following staff members participated in these supplemental outreach events: Sheysa Ojeda and Sheryll Perez (Assignment Desk Manager-TV and Communications and Community Affairs Director- TV), Manuel Santiago (Production and Operations Director-TV), Elsie Grana (Senior Sales Executive-

TV), Ezequiel Cabán (Production Supervisor-Radio), Javier Cosme (News Director-Radio) and Luani Pellot (Programming Director-TV).

The event was advertised in the stations' daily TV newscasts 5:00pm edition from Thursday September 4 through Monday September 8 and on Tuesday September 9 in the 12:00pm edition. The event was also advertised on radio stations (WKAQ-580 and KQ-105) during three (3) consecutive days before the event from Thursday through Monday. On Wednesday, September 10th, the newscast segment "Por un Puerto Rico Mejor" presented a summary of the event, along with pictures, as the positive note of the day. Students were active in social media (Twitter) posting comments about employment unit managers' presentations.

The event had a positive reception from the community. For both events we received total cooperation from both universities.

Provision of Training:

On September 25, 2014 the employment unit conducted an EEO/Non- Discrimination training hosted by its HR Manager- Jeannette Reyes. A total of 29 managers and supervisors from TV & Radio participated in the training.
